Three scholarships will be awarded on the state level in the amounts of \$3,000, \$2,000, \$1,000 and \$500 on the regional levels. They may be used by Iowa high school seniors for their first year of education on the college level. Students should be sure to submit their application to the Conservation District in which they live.

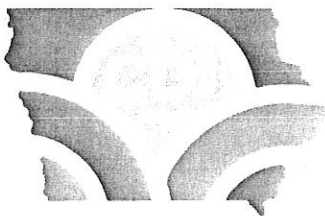
Criteria considered for the scholarship award will be 20 points for Involvement, Leadership, & Character, 20 points for Career, 30 points for Scholastic Achievement and 30 points for Conservation Message. Please note: **Applicants need to be entering into a field of Conservation or Agriculture to qualify.** As this is a wide field, preference will be given to students pursuing programs of study in conservation. The scholarship must be used for the student's first year of college education.

Applications need to be submitted to the Dubuque Soil and Water Conservation District by February 10, 2023. Also available online at <https://cdiowa.org/get-involved/scholarships/>. Entries received after this date will not be accepted. Students will be informed in mid-May if they have been awarded a scholarship.
